### **Is the product effective against Human Coronavirus?**

Yes, the product kills viruses like Human Coronavirus as well as MRSA, Influenza Type A, Rotavirus and more.

### **Is the product approved by the Environmental Protection Agency (EPA)?**

Yes, the product received EPA approval in 2004.

### **Is the process or product harmful to humans or animals?**

No, after the product dries it is inert (chemically inactive).

### **How long does the service take?**

We can apply disinfectant to 2,500 square feet in 30 minutes or less. The product takes 10 minutes to kill the microorganisms and it takes 15 minutes for the product to dry.

### **Where in my facility can this service be used?**

We can apply disinfectant to any areas, including fitness spaces, restrooms, locker rooms, offices, public spaces, and cafeterias.

### **What surfaces is the disinfectant applied to?**

We can apply disinfectant to surfaces including equipment, weights, mats, door handles, light switches, window, mirrors, etc.

### **We already clean our facility so why do we need this?**

Our service applies disinfectant to all surfaces and kills viruses and bacteria in 10 minutes, including hard-to-reach areas.

### **Does the product clean the facility?**

No, the product we apply is a one-step, broad-spectrum disinfectant.

### **Is the service safe to use around and on electronics?**

Yes, our application tool is used on the finest mist setting.

### **How long will the facility be disinfected?**

The product we apply kills and disinfects all present microorganisms in the facility.

### **What do I need to do before the service?**

A checklist will be shared prior to your service but preparation includes making sure all surfaces where we will apply the disinfectant product are accessible.

### **What do I need to do after the service?**

Wait at least 15 minutes before returning to area. If an area is wet, let air dry, DO NOT WIPE DRY. Some objects will have a little film so once dry you can polish as needed.

### **What is electrostatic spraying and is it new?**

Electrostatic disinfecting works by providing a charge to a solution so that it electromagnetically sticks to a targeted surface, providing 360-degree coverage. It has been used for more than 60 years in agriculture and automotive industries and more recently in healthcare settings.

### **What is does Certified Master in Infection Prevention mean?**

To become a CMIP someone must complete a robust 30-hour certificate program to meet the requirements to become a trained professional in infection prevention and control. The program includes the most important topics in infection prevention: worker safety; surveillance, risk assessment, outbreaks; evidence-based cleaning practices and environmental monitoring; preventing infection during construction and mass casualty events.
